FACTS	WHAT DOES LOUISIANA EDUCATION LOAN AUTHORITY (LELA), A DIVISION OF THE LOUISIANA PUBLIC FACILITIES AUTHORITY (LPFA), DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  Social Security number and transaction history  account balances and payment history  credit history and account transactions
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons LELA chooses to share; and whether you can limit this sharing.

How does LELA protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  We also require our servicers to maintain physical, electronic, and procedural safeguards that comply with federal standards to protect your personal information.			
How does LELA collect my personal information?	We collect your personal information, for example, when you			
Why can't I limit all sharing? Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
	Nonaffiliates we share with can include government entities, audit firms, credit bureaus, companies that perform marketing services on our behalf, and companies that assist in servicing your loan(s) with us.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
